United Kingdom was a *marginally adequate* performer under the Voiceless Animal Cruelty Index (VACI) 2017 (on par with China).

Producing Cruelty

Rank 20

The United Kingdom kills 15.6 animals per person / year compared with a global average of 10.6. This is lower than France (16.8) but higher than Germany (10.1). Sow stalls have been banned in the UK since 1999 [https://www.ciwf.org.uk/our-campaigns/pigs/]. In common with other EC countries, barren battery cages are illegal, but furnished cages are allowed. Layer hens, broilers and pigs [https://www.theguardian.com/environment/2016/apr/24/real-cost-of-roast-chicken-animal-welfare-farms] are mostly produced in factory farms.

Consuming Cruelty

Rank 41

Land animal protein in the diet is close to 54%. This is much higher than the world average (35%) but lower than most of the EU members surveyed. In 2014 the UK also had the most vegetarians in Europe, with 12% of the population, according to a survey [http://www.express.co.uk/life-style/health/517246/Vegetarians-are-on-the-increase-in-Britain]. This represents a major increase that coincides with a proliferation in the types and quantity of vegetarian and vegan food available [https://www.mintel.com/press-centre/food-and-drink/number-of-global-vegetarian-food-and-drink-product-launches-doubles-between-2009-and-2013]. According to the 2011-12 National Diet and Nutrition Survey

Sanctioning Cruelty

Rank 8

The United Kingdom was close to best practice with respect to the quality of its animal welfare legislation, and was given an "A" under the Animal Protection Index (API) 2014. It was the first country in the world to implement animal welfare legislation.
